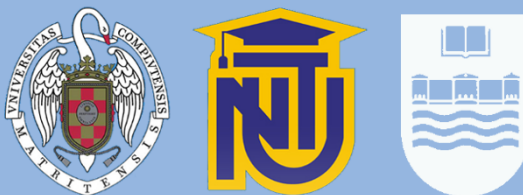
REGISTRATION FEES
